Laura Kingsley Hong has nearly 40 years of uninterrupted trial experience defending class action, mass and toxic tort, product, and commercial litigation.

Laura recently completed her seven-year term as Chair of the firm's Mass Tort Product Liability Group. She serves as national, trial, and local counsel for many companies. Laura tries cases and manages and assists local counsel, insurance companies, and corporations in the defense of mass and toxic tort and product liability claims. Laura also has a robust commercial litigation practice. She appears in state and federal courts across the country and has tried several cases to jury verdict. Laura often partners with counsel from other law firms, providing clients a cohesive and collaborative defense team. She routinely participates in mediations, often with JAMS, and has also arbitrated before the American Arbitration Association.

Laura was featured in the "Big Suits" column in *The American Lawyer*, detailing a victory on behalf of BP involving a 19-week refinery contamination trial. Laura's testimony in favor of legislative initiatives to curb lawsuit abuse has helped shape that legislation, and her testimony supporting Ohio's Asbestos Medical Criteria Bill (Ohio H.B. 292) is cited in the legislative history.

Laura is ranked in Chambers USA 2024 in the area of Product Liability: Toxic Torts (Nationwide) and Product Liability & Mass Torts (Nationwide). Most recently, to raise consciousness on wrongful convictions, Laura is involved in fundraising for the opera production of Blind Injustice, which will be performed at Cleveland's Playhouse Square in July 2025. The Opera recounts the stories of six exonerees through blues, jazz, rap, and gospel.
