Our Methodology

The Leopard Law Firm Index is based on key weighted indicators of law firm sustainability and eliminates the bias for relative law firm size.

These factors include:

The Leopard Law Firm Index was created to provide a unique insight into each firm in our database. Our ranking metrics were formulated to provide a true picture of firm stability by using data that is not 'gameable' by the players in the industry. Firms looking at strategies to improve their index score will vary by individual firms and are based on each firm's history, capabilities, and aspirations. This is an ever-changing metric as firms change throughout the year.

We see firms each year that go under but are still ranked among the top firms in the country by other ranking systems.
